Nitragin[®] inoculants are cultures of nitrogen-fixing nodule bacteria in a peat-base medium prepared for application to legume seed before planting. Rhizobia working in nodules gather nitrogen from the atmosphere and make it available to the plant.

CAUTION:

Store in cool place. Use before expiration date and only on specified legume seed. Protect inoculated seed from sunlight or drying winds. Avoid contact with strong fertilizers. Plant inoculated seed within 24 hours. DRY METHOD

Pour NitraStik-GC onto seed in the drill box and mix thoroughly until uniformly coated. Layering seed and inoculant while mixing will provide thorough coating of all seeds.
